**DEFINITIONS**

**HISPANIC:**

A person of Mexican, Puerto Rican, Cuban, Central or South American, or other Spanish culture or origin, regardless of race.

**BLACK, NOT OF HISPANIC ORIGIN:**

A person having origins in any of the black racial groups of Africa who is not of Hispanic origin.

**ASIAN OR PACIFIC ISLANDER:**

A person having origins in any of the original peoples of the Far East, Indian subcontinent, Southeast Asia, or the Pacific Islands. This area includes, for example, China, Japan, Korea, the Philippine Island, and Samoa.

**DISABLED VETERAN:**

A person entitled to disability compensation under laws administered by the Veterans' Administration for disability rated 30 percent or more, or a person whose discharge or release from active duty was for a disability incurred or aggravated in the line of duty.
